The present General Terms and Conditions of Sale govern the relationship between "Classique Attitude Ballet Dubai" and its Client for the services set out below.

Any Client which orders a dance class offered for sale by "Classique Attitude Ballet Dubai" implies full and complete acceptance of these General Terms and Conditions of Sale, which the Client acknowledges having read prior to ordering.

1. Presentation of "Classique Attitude Ballet Dubai"

"Classique Attitude Ballet Dubai" is a company under local law (LLC) whose activity (Sport Services license) is carried out in Sole Establishment. The dance school "Classique Attitude" was created in France in Aix en Provence in 2010 by Domitille LEDOUBLE.

2. Services offered

"Classique Attitude Ballet Dubai" offers the sale of a range of dance classes whose work - of ballet aesthetics - based on the sensitivity of the soul translated by the expressive and evolving body.

3. Contributions

"Classique Attitude Ballet Dubai" reserves the right to modify its fees at any time. However, it undertakes to invoice the services ordered at the prices indicated at the time of registration.

4. Commitment at the time of registration

When you register your child or yourself for the year, you benefit from a preferential rate because of your commitment over this period. Trial lessons are offered, payment per lesson (per unit) is possible, cards of 10 lessons or quarterly subscriptions are offered to meet the needs of children and/or parents who may change their mind, situation or motivation during the year. We therefore ask you to choose the subscription that suits you best as courses are non-refundable.

5. Subscriptions and payments

Subscriptions are calculated from date to date : from 16/10/2024 to 16/01/2025)

- ✓ Possibility of paying the quarterly rate in 2 instalments.

6. Operation

- Mobile phones are strictly forbidden during lessons. If necessary, the reception phone can be used.
- It is advisable to look after personal belongings in the changing rooms. The management declines all responsibility in the event of theft or loss on the premises. A dedicated lost and found storage area will be available.



- Everyone must ensure that they respect others and the school team, both in terms of behaviour and respect for basic hygiene rules.
- The wearing of street shoes is strictly forbidden in the studio, especially on the dancers' floor.
- Students are requested to arrive 5 minutes before class, out of respect for the teacher and the other students (any student arriving very late will be refused entry). In case of absence, please inform the teacher, so that a missed class can be made up as far as possible. A class can only be made up during the subscription period.
- The School's insurance covers all members for their civil liability only. It is therefore strongly recommended that you check that you are covered by personal insurance.
- The teacher has the right to cancel a class if less than 3 students are present.

7. Image Rights

"Classique Attitude Ballet Dubai" organizes Gala Evenings and various events (workshops, MasterClass, ...) in the presence of photographers. If you do not wish your child or yourself to be photographed, we would be grateful if you could inform the management at the time of registration.

8. Force majeure

The responsibility of "Classique Attitude Ballet Dubai" cannot be implemented if the non-performance or delay in the performance of one of its obligations described in these General Terms and Conditions of Sale results from a case of major force. In this respect, major force means any external, unforeseeable and irresistible event.
